# RETINECY (RTNC) PRIVACY POLICY — AEGIS EDITION

Public Privacy and Data Handling Policy for RTNC

# 1. INTRODUCTION

This Privacy Policy explains how RTNC collects, uses, stores, and protects user information.

RTNC is committed to transparency, data minimalism, and user protection.

# 2. ROLE OF AEGIS

Aegis is the permanent title of the Caretaker (CT).

Aegis does not collect personal data, does not store user information, and does not engage in any form of data profiling.

Aegis only oversees transparency and operational publication of RTNC statistics.

# 3. DATA RTNC COLLECTS

RTNC collects the minimum data necessary for website functionality:

- basic server logs (IP, device type, request metadata)
- anonymous analytics (optional, if enabled)

RTNC does NOT collect:

- personal identity information
- wallet private keys
- financial data
- mining performance metrics tied to individuals

#### 4. BLOCKCHAIN DATA

The RTNC blockchain is public and transparent by design.

Any transaction broadcast by a user becomes part of the public ledger.

RTNC does not control, modify, or censor blockchain data.

# 5. COOKIES & ANALYTICS

RTNC may use:

- session cookies
- optional performance analytics

These cookies do not extract personal information and are used only for stability and performance monitoring.

Users may disable cookies in their browser.

# 6. THIRD-PARTY SERVICES

RTNC may link to third-party platforms such as exchanges, wallets, or block explorers.

RTNC is not responsible for:

- data collection by third parties
- their privacy practices
- their compliance with regulations

Users interact with third-party services at their own risk.

#### 7. DATA SECURITY

RTNC employs standard security protections including:

- encrypted connections
- secure hosting infrastructure
- limited log retention

However, no system is immune to attacks. RTNC cannot guarantee complete immunity from breaches.

#### 8. USER RIGHTS

Users have the right to:

- restrict cookies
- · avoid third-party integrations
- not provide any personal information

RTNC does not operate accounts, custody, logins, or identity-based services.

#### 9. CHILDREN'S PRIVACY

RTNC does not knowingly collect information from minors.

Use of RTNC services by minors must comply with local laws.

#### 10. DISCLOSURE OF INFORMATION

RTNC does not sell, trade, or transfer user information.

Information may only be disclosed if legally required by law enforcement authorities.

Aegis does not provide private user data because none is collected.

# 11. DATA RETENTION

RTNC retains minimal server logs for security and operational integrity.

Logs are purged periodically and are not tied to personal identity.

#### 12. CHANGES TO THIS POLICY

RTNC may update this policy to reflect changes in technology, legal requirements, or operational needs.

Updates will be published publicly.

Continued use of RTNC services constitutes acceptance of updated policies.
